No. 62719-591) on cottonwood/poplar trees grown for pulp was issued as a replacement SLN.

VOLUNTARY CANCELLATION FOR 24C SPECIAL LOCAL NEEDS LABELS

Dow AgroSciences (DAS) wishes to support EPA clean-up efforts related to Special Local Needs (SLN) 24(c) registrations for Lorsban[®]-4E (EPA Reg. No. 62719-220) which are no longer active and/or have been superseded by Section 3 main labeling or SLN's for other chlorpyrifos-containing products. As you are aware, several SLN's for the new product Lorsban[®] Advanced (EPA Reg. No. 62719-591) have been established and DAS has requested voluntary cancellation for the comparable Lorsban-4E SLN's in several phases. Last week DAS requested voluntary cancellation of the final list of remaining Lorsban-4E SLN's to complete this changeover process. Since that time, we discovered that three SLN's had inadvertently been left off this list, so we are sending a follow-up request.

In accordance with FIFRA Section 6(f)(1), DAS hereby requests voluntary cancellation of the following Special Local Needs 24(c) registrations for Lorsban-4E (EPA Reg. No. 62719-220):
